Health Mastery Institute (HMI) and the above named student with signature associated hereto enter into this enrollment agreement, a legal and binding agreement whereby the student will pay tuition and fees as indicated below, due in United States Currency (USD), as well as adhere to the Institute's policies as outlined herein.

HMI Holistic Health Coach Certification Requirements

To receive Coaching Certification from HMI, the candidate for HHC must:

1. Complete all requirements for his or her program of study within 18 months from original enrollment date. The program is designed to be completed within 8 months, but students can take up to 18 months to complete the program. If the program is not completed within 18 months, the student will not be able to graduate.
2. Fulfill all financial obligations to HMI prior to certification.
3. If student is on the monthly payment plan, and payment is late or unpaid within 14 days after due date, student access to learning materials and to the group will be suspended until payment is made current.

Standards of Academic Progress

A student's academic progress is considered satisfactory when:

- a) the student completes each assignment for each module of learning, and scores 70% or higher
- b) the student completes all required course components, including the Final Exam (submission of Health Histories/completion Health Coaching Sessions)

Failure to maintain Satisfactory Academic Progress will trigger Academic Probation. This could lead to Dismissal. Evaluations occur halfway through the program and at the conclusion of the program.

Notice of academic status changes (including Probation and Dismissal) will be made by the Education Director to the student within three calendar days of any such determination. This notice will be by e-mail as a letter delivered as a PDF file.

ADDITIONAL TERMS

Program Completion

HMI Nutrition is designed to be completed within an eight month timeframe, but flexibility is built into the program that allows the student up to 18 months to complete the coursework.

Software and Content Licenses

Monthly Payment Details

If you opt for the monthly payment, HMI will invoice Student each month. Payment is due each month by the 5th. Student will not be able to continue on in the program and in the online groups until payment is made current.

Withdrawal

If a student has to withdraw from the Institute for any reason, their previous payment can be credited towards completion of the program, based on whatever the current rate of tuition is at the time of re-enrollment, and at the sole discretion of the administration.

Online Group
